## **Membership Policy and Fee Structure**

ATSIMA has a membership structure consisting of:

- 1. Affiliate Membership
- 2. Ordinary Membership
- 3. Association Membership.
- 1. Affiliate Membership no voting rights at the Annual General Meeting (AGM) but can attend the AGM

As an affiliate member, you will receive notifications of ATSIMA activities and events. There is no cost to be an affiliate member. You do not have to renew your membership each year if you are an affiliate member.

2. Ordinary Membership - voting rights at the Annual General Meeting

This membership type is available to Aboriginal and Torres Strait Islander people. Ordinary Membership categories are:

- $\circ$  Individual
- Students (full time student at a recognised high school or tertiary institution)
- Aboriginal and Torres Strait Islander Organisation (an Aboriginal owned company incorporated under The Office of the Registrar of Indigenous Corporation (ORIC) or an Incorporated body that is Aboriginal owned or has an Aboriginal Board).
- **3.** Associate Membership no voting rights at the Annual General Meeting but can attend the AGM

This membership type is available to non-Aboriginal and Torres Strait Islander people. Associate Membership categories are:

- o Individual
- Students (full time student at a recognised high school or tertiary institution)
- Organisation.

### **Membership Period**

July to June (a financial year) – Renewals occur from March to September of each year. If a member does not renew membership by 30 September, the membership ceases.

For new members, membership commences on the date on which the membership is lodged and the fee is paid. If membership is joined on, or after, the 1 March, the membership will continue through to the end of June the following year.
